The Purpose of Text Messages

Short message service (SMS) is also called text messaging. The use of text messaging to discuss your health is voluntary. You can ask to stop getting these texts at any time by calling our main number.

Risks of Using Text Messages

Sending and receiving texts has risks. These include, but are not limited to the following:

- Your doctor may share protected health information (PHI) with you through standard texts. These texts may not be secure. This means that the messages are not encrypted (coded so others cannot read them) while in transit from the doctor to your phone.
- Texts can be sent or forwarded to anyone without the original sender's knowledge. Texts might be sent to the wrong person. A risk of using text messages happens if you change your mobile number. In this case, a message transmitting confidential information could be sent to another person's device.
- Copies of texts can be kept on mobile devices for a long time, even after the original message has been deleted. This may allow someone you do not know to see your messages. This could happen if the mobile device is recycled, stolen, or lost.
- If your mobile device is not password-protected, anyone can see your text messages.
- A text message can go to multiple devices (e.g., an iPhone and an iPad that use the same Apple ID) even if they are sent to only one phone number.
- If you use your work device to send or receive texts about your health, there is a chance that your employer could read these messages.
- If you send a text message to your doctor, you may not get an answer right away.
- Talking with your doctor or office staff about sensitive subjects through texts is risky. Other people might see messages about your mental health, reproductive health, substance use, HIV status, or genetic disorders. To protect your privacy, talk with your doctor about these topics in person or on the phone.
- Never use text messages for an urgent problem or in an emergency. If you think you have a medical emergency, call 911, go to the nearest emergency room, or call your doctor right away.
